1.) PennDOT Stockpile Lease

Solicitor Fisher explained that there is nothing to discuss at the present time, and to include the stockpile lease matter on future agendas until action from the Board would be required.

NEW BUSINESS:

- 1.) East Penn Chamber of Commerce "Welcome" Sign Initiative
 - a. East Penn Chamber of Commerce approval request letter, dated April 7, 2015

John Hayes, a resident of the Township and a member of the East Penn Chamber of Commerce Board of Directors, summarized the intention and location of the proposed "Welcome" signs. The East Penn Chamber of Commerce is requesting the Board's approval to place three (3) signs within the Township. One sign will be placed in front of the Township's Municipal building and a second sign will be placed in front of Jasper Park. The third sign, welcoming persons to Macungie, is being requested to be placed within the Township boundary. This request is placed before the Board because the Macungie Borough will only allow the sign to be installed within its boundary if it complies with their zoning ordinance, which it does not. The East Penn Chamber of Commerce does not have a budget for variance fees. The signs will measure 30 inches wide by 36 inches in height. Each sign will be sponsored by a business to cover the cost of the sign. Each sign includes a five (5) year warranty. The East Penn Chamber of Commerce is also requesting to have the signs installed by the Township's Public Works Department. Supervisor Sentner asked how the signs comply with the Township's Zoning Ordinance. Manager DeLong answered that the Township's Zoning Officer interpreted the signs as informational, thus complying with the Township's Zoning Ordinance.

PLANNING COMMISSION - NEW BUSINESS:

1.) Receipt of Minor Subdivision for Kohler Tract, 4475 Mill Road; Township will need to address implications due to official plan requirements.

Manager DeLong summarized that the Township received an official plan submission for a minor subdivision, which is intended to lead to a major subdivision of 142 lots. The property is on the official Upper Milford Plan, which has some designations and requirements that will have to be met. This will require Board action early on in the review process. Supervisor Sentner reminded the Board members that the next regularly scheduled Planning Commission meeting will be held on May 4, 2015 at 7:30 P.M. Submissions of a sketch plan and a minor subdivision plan for the subject subdivision will be occurring at that meeting. Sentner expressed the importance of the Township's Planning Commission hearing the Board's feedback from the "get-go". The public is welcome to attend the meeting as well.

Manager DeLong summarized for the Board that the Township does not want the developer to complete a final paving of the development until they are nearing completion of the homes due to the damage caused to the street by the construction vehicles. Trends in development are changing. Economically, money flow is improving and prices are rising. The Township is seeking to raise the security posting of the developer by ten (10) percent. Legally, the Township is allowed to increase the security posting by ten (10) percent, which is a cap set on security posting increases.
