AMENDMENTS TO ORDINANCE NO. 18

WHEREAS, on or about March 1, 1967. the Board of Supervisors of Upper Milford Township adopted an Ordinance entitled "AN ORDINANCE REGULATING THE TRANSPORTATION BY MOTOR VEHICLE OF HOUSEHOLD GOODS FROM PLACE TO PLACE WITHIN THE TOWNSHIP OF UPPER MILFORD OR FROM PLACES WITHIN THE TOWNSHIP OF UPPER MILFORD TO POINTS BEYOND THE LIMITS THEREOF; AND PROVIDING FOR THE ISSUANCE OF PERMITS, FOR THE TRANSPORTATION THEREOF, BY THE SECRETARY-TREASURER OF THE TOWNSHIP OF UPPER MILFORD"; and

WHEREAS, after careful review, the Board of Supervisors of Upper Milford Township are desirous of amending said Ordinance.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Supervisors of Upper Milford Township, Lehigh County, Pennsylvania as follows:

- 1. Ordinance No. 18 shall hereinafter be entitled as: "AN ORDINANCE REGULATING THE MOVEMENT OF PERSONS WITHIN UPPER MILFORD TOWNSHIP AND FROM UPPER MILFORD TOWNSHIP TO PLACES BEYOND THE LIMITS OF UPPER MILFORD TOWNSHIP; PROVIDING FOR THE ISSUANCE OF MOVING PERMITS, AND PROVIDING FOR PENALTIES FOR ANY PERSONS WHO FAIL, OR REFUSE TO COMPLY WITH THE REQUIREMENTS OF THIS ORDINANCE".
- 2. Section 1 of the Ordinance shall now read as follows: "No person or persons, firm, corporation or other entity, shall

55 BROADWAY JIM THORPE, PA 18229 move from place to place within Upper Milford Township or from Upper Milford Township to any place beyond the limits of Upper Milford Township, without first securing a permit for such movement."

- 3. Section 2 of said Ordinance shall hereinafter read as follows: "Any such person or persons, firm, corporation or other entity desiring such a permit shall make an application to Upper Milford Township setting forth his/her and/or its, their name and address, the names of the owners or reputed owners of the property, the address and location from which they are moving from and the new address or location of the place to which they are moving to."
- 4. Section 3 of the Ordinance shall hereinafter read as follows: "Upon application being made meeting the requirements of Section 2 above, the Township shall issue a permit."
- 5. Section 4 of said Ordinance shall hereinafter read as follows: "Any person or persons, firm, corporation or other entity who shall fail to comply with the provisions of this Ordinance, or provide any false information shall, upon conviction, be sentenced to pay a fine of not more than Three Hundred Dollars (\$300.00) and/or be sentenced to a term of imprisonment not exceeding ten (10) days.
