# Fire Company Steering Committee:

1.) Fire Company Month of June Report.

Assistant Manager, Haas summarized both Fire Department's call report from the month of June. Western District had seven (7) calls, two (2) of which were mutual aid. Citizens' Fire Company had 16 calls, one (1) of which was mutual aid. Haas also updated the Board on the status of Solicitation permits. Per Resident, Phil Casey's request, all active Solicitation license holders within the Township are now posted on the Township's website.

Supervisor Sentner mentioned to the Board that Ms. Lynn Sallash attended her first Fire Company Steering Committee meeting as the newly appointed Citizen at Large. It was a successful meeting and he is looking forward to moving forward with her.

# Supervisors:

Robert Sentner - Stressed that the intention of the Board is not to merge the two (2) Fire Companies. He will be attending the Fire Company meetings to reiterate that the creation of the Fire Company Steering Committee is not to merge the Fire Companies.

> He wrote a letter as a resident of the Township (not as a Supervisor) in response to the Lehigh Valley Regional Freight Plan. He is not happy at the speed of which things are being done. He would like to start a new group (possibly comprised of PennDOT, concerned citizens, planners, etc.) that would deal solely with traffic and roadway concerns. He later reneged this request.

> Discussions ensued regarding the system and process of planned developments for roadways and transportation logistics. Manager, DeLong does not believe that creating a new committee would be beneficial, but people need to begin working within the system and begin attending the meetings that are held to discuss such issues. There's not enough money to get everything done. Supervisor Sentner agreed. Resident, Francis Caputo also agreed and stressed to the Board and the audience that people need to address these issues with local legislation. Supervisor Mohr expressed his frustration in the lack of freight being moved by train.

Daniel Mohr –

Shared how he saw tire tread along Vera Cruz Road North. He wondered when it will be removed. Public Works Foreman, Brent
