## **OLD BUSINESS**:

1.) Chestnut Street Roadway Improvements (Discussion)

Supervisor Sentner discussed trimming of the Hedge at Rt. 29 and Shimerville Road to help improve traffic flow. He asked if it's possible to reach out to the homeowners to see if there would be cooperation to ease some concerns along the roadway. He also highlighted that the Southwest Comprehensive Plan may help with long term goals. Supervisor Mohr discussed that larger signs at Beck Road have not been installed by PennDOT as the Township had been told they would be.

Manager DeLong said the Norfolk Southern Rail Road Bridge Plans should be ready by the end of May. There are also pending traffic studies for Chestnut St from Emmaus to Mill Rd. completed by Benchmark Engineering. These should also be ready by the end of May.

Manager DeLong will send a letter to the homeowner in regards to the Hedge along Rt. 29 at Shimerville Road.
