1.) Ordinances 162, 163 and 164 – For Act 167, Stormwater Amendments a. Letter from Planning Coordinator Brian Miller

Letter from Planning Coordinator Brian Miller outlined the Amendments to the 3 stormwater Ordinances for the Little Lehigh, Perkiomen Creek and the Saucon Creek. The amendments increase the impervious area to 10,000 Sq. Ft. before a drainage plan is required for a Normal Agricultural Operation and exempt certain decks, the water surface area of a swimming pool, Forest management and Timber Harvest activities and high tunnels as specified in the Storm water management Act. The Amendments include definitions for Normal Agricultural Operation & Forestry. The amendments were recommended for approval contingent on staff and Solicitor approval by the Planning Commission on March 4th, 2019. The Ordinances are ready for advertising and beginning the adoption process.
