PUBLIC INPUT:

<u>James Krippe</u> – Mr. Krippe questioned the Solar Farm in Lower Macungie Township. He felt that the plan he saw had solar panels on a 5+ acre parcel within Upper Milford Township. He stated this parcel was across from the Farmhouse on Tank Farm Rd near the intersection of Raymond Court. 3760 Tank Farm Rd.

Planning Coordinator Brian Miller stated he would look into it, however he did not think any of that project was within Upper Milford Township.

OLD BUSINESS:

1.) Kay Builders – Engleman Tract

Shawn Duly from Keystone Consulting Engineers Inc was present to speak about the Engleman Tract Concept plan that has been submitted to the Township. Mr. Duly stated that the Board had asked them to do the traffic study and that has been done and gone over by Township Staff, PennDOT and Peter Terry of Hanover Engineering, The Township's Traffic Engineer. He was now presenting the concept plan that follows the Township lot size and setbacks for Suburban Residential Zoning District which Kay Builders is asking the Board to extend to cover this parcel. Right now the Parcel is zoned industrial and they are asking for Suburban Residential.

Supervisor Zgura stated that he felt there was too many houses on this plan and would like the Planning Commission to take a look at the plan and give their recommendation for the Zoning Change. Supervisor Moore and Mohr also agreed with that. There was a brief discussion.

MOTION: Supervisor Moore made motion to send this sketch idea to the Planning Commission for their input into the matter. Supervisor Zgura seconded the motion. Hearing no further questions or comments, all were in favor, motion carried.

NEW BUSINESS:

1.) Zoning Hearing Board appointments a. Memo from Manager Carter

With John Zgura resigning from the Zoning Hearing Board, I would ask the Board of Supervisor to make the following appointments: Appoint Samuel Cohen, who is currently an alternate on the Zoning Hearing Board to fill the remainder of John's terms that expires on December 31, 2024. Appoint Aurora Pattishal to fill the Alternate Zoning Hearing Board position held by Samuel Cohen that expires on December 31, 2022. There is another Alternate Zoning Hearing Board positions that was to be filled by Sarah Powell, but after the Board of Supervisor appointed her, she has not shown an interested it that position.

MOTION: Supervisor Moore made a motion to appoint Samuel Cohen, Aurora Pattishall, and Frank Reith as listed in Manager Carter's memo dated September 9th, 2021. <u>Supervisor Zgura seconded the motion</u>. Hearing no questions or comments, all were in favor.

- 2.) Natural Resources Conservation Easement Appraisals and Recommendations - Wachter & Miller
 - a.) Letter from Secretary Jessi O'Donald

At their September 8^{th,} 2021 meeting, the Upper Milford Open Space Committee discussed two appraisals for Natural Features Conservation Easements. 4302 Main Rd West/5760 Vera Cruz Rd the Owner is presently working with Lehigh County Agricultural Land Preservation on a 48.6872 acre easement. The Natural Features Conservation Easement that has been applied for with the Township is the approximate remaining +/- 43.7 acres of the property. This land is in the LVPC High Priority area and contains flood plain/buffer area, steep slopes and wetlands along the Cold water fishery of the Liebert Creek. The Conservation Easement Appraisal noes a value of \$3,210 per acre for the Easement, for a total value of approximately \$140,277.00. 7447 Salem Bible Church Rd. This +/-40.5 acre property is located within the Perkiomen Watershed and contains Natural Heritage Inventory Supporting Landscape, Steep Slopes and a large section of Inland Woodland. This property is located within the highest priority conservation area in the LVPC Natural Resources Mapping & the Schuylkill Watershed Land Prioritization Strategy Mapping. The parcel is also in a large wooded section of the Township where there are no dwellings in an area of over 300 acres. The Conservation

Easement Appraisal notes a value of \$4,930 per acre for the Easement, for a total value of approximately \$199,665.00. The Open Space committee recommends the Board of Supervisors complete the process to purchase the Conservation Easements for both properties. This would entail completing the necessary property surveys, creating the Baseline documents and completing the legal agreements to finalize the purchase of the Easements

MOTION: Supervisor Moore made a motion to continue with the surveying, baseline documentation and legal agreements for the Natural Resources Conservation Easements for 4302 Main Rd West/5760 Vera Cruz Rd and 7447 Salem Bible Church Rd. Supervisor Zgura seconded the motion. Hearing no questions or comments, all were in favor, motion carried.
