<u>Jim Krippe</u> asked for clarification of the Federal recovery money he questioned at the prior meeting. Mr. Krippe states he had been questioning the ARPA Funding money and wondering if the Supervisors knew if it was received. Supervisor Moore stated in was held in a separate fund. Treasurer Jessi O'Donald responded that the CARES Act money was approximately \$110,000.00 and the ARPA Funding was received at ½ of approximately \$804,000.00 in June and also held in a separate account. The other half will be received in June 2022.

\*Note CARES ACT total: \$110,015.64 and ARPA received in 2021: \$416,060.12.

## **NEW BUSINESS:**

1.) Adoption of Tentative 2022 Budget

a. Memo from Secretary/Treasurer O'Donald

Before you this evening is the 2022 proposed budget. Since receiving the Draft Budget on October 21<sup>st</sup>, there have been two minor adjustments. First adjustment was notification from PSATS-UC Trust that due to 2020 UC Claims our rate of contribution will be increase from .09 to 3.75 for 2022. The second adjustment was to cover a possible MMO change for the PASB-MRT Defined Benefit Pension Plan. We received notification from Byer-Barber with a recommendation to adjust the MMO for the PSAB-MRT Defined Benefit Plan for the 2022 plan valuation. This has been sent to the Pension committee and we are waiting on a few questions to be answered before making a recommendation to the Board. Since there was not time to make a full recommendation to the Supervisors on the MMO prior to finalizing the budget we thought it prudent to include the expense. If the MMO for the Defined Benefit Plan is adjusted the Board will have to acknowledge that adjustment through a motion at a later date. Both of these increases were adjusted from the MS4 expense line item.

Supervisor Moore questioned how the referendum for Open Space worked and if it expired for 2023. There was a brief discussion and Staff will verify the workings of the Referendum and report next meeting.

<u>MOTION</u>: <u>Supervisor Moore made a motion</u> to approve the tentative Budget and Advertise for Public Review. <u>Supervisor Zgura seconded the motion</u>. Hearing no questions or comments, all were in favor, motion carried.

2.) 2022 Lehigh County Humane Society Contract

a. Memo from Secretary/Treasurer O'Donald

The contract for 2021 has been a good partnership between the Lehigh County Humane Society and the Township. Residents have been able to TNR (Trap/Neuter/Release) 20 feral cats from colonies within the Township. This helps keep the feral cat population under control. Residents have also had a place to take stray dogs and friendly cats to have help in finding their current owners or new homes. For 2022 the LCHS has offered a 3 year contract for \$825.00 per year. This is just a \$25.00 increase from 2021. The contract allows for the intake of all stray and relinquished dogs as well as 20 friendly cats into the shelter and the TNR of an additional 20 cats for the control of feral populations. Approval of this contract also allows the resident of Upper Milford Township access to the community veterinary clinic at contract prices. The contract is included in the proposed 2022 budget and is presented tonight with a recommendation to approve if the Board is in agreement.

MOTION: Supervisor Zgura made a motion to approve the three year contract with the Lehigh County Humane Society for \$825.00 per year as stated in Jessi O'Donald's memo dated November 4<sup>th</sup>, 2021. Supervisor Moore seconded the motion. Hearing no questions or comments, all were in favor, motion carried.

After discussion the Planning Commission recommended having Township staff begin the process to create a Coordinated Zoning Overlay District to create standards for allowing a planned residential use on Industrial zoned property for the purpose reducing conflicting land uses at 4650 Indian Creek Rd.

Supervisor Zgura stated that felt the PC meeting went well and everyone was able to have a conversation this time around. He was glad the Board had been able to meet with the PC and have a discussion.
