1.) Lot Line Adjustment – John & Annabelle Fegley – Kings Hwy N a. Letter from planning Coordinator Brian Miller

At their meeting August 29th, 2022, the Planning Commission recommended granting approval for the John Fegley Boundary line adjustment plan contingent upon addressing the following items:

• Copies of the written temporary parcel description and final deed descriptions shall be forwarded to the Township.

• All pins to be set shall be completed and certified by the Surveyor in writing to the Township prior to plan recording.

• The record plan shall note zoning variance approval date, section granted & a brief description.

• Zoning Hearing Board approval for any required variances. Since that meeting the applicant has received a favorable decision from the Zoning Hearing Board to Article 3, Section 313.C.12.b.(ii) (Accessory Structure side yard setback). If you agree a motion to approve the John Fegley Boundary Line Adjustment should be made contingent on addressing the items in this letter.

2.) Credit Release Number 2. – Estates at Maple Ridge a. Letter from Township Engineer Jeffery Ott

In accordance with the request for release of secured funds dated August 25, 2022, we the undersigned hereby certify that the improvements required in connection with the Estates at Maple Ridge, have been completed to the extent that the Financial Security Agreement can be reduced by

the amount of Two Hundred Twenty- Eight Thousand, Nine Hundred Thirty-Six Dollars and Fifty-Eight Cents (\$228,936.58), in accordance with the Subdivision Improvements Agreement dated May 11, 2022. This certificate authorizes the Penn Community Bank to reduce said amount, namely Two Hundred Twenty- Eight Thousand, Nine Hundred Thirty-Six Dollars and Fifty-Eight Cents (\$228,936.58) to owner or such other person as said owner shall designate. This authorization shall not be construed as final acceptance of improvements made to date.

In no event, shall the escrow fund for the construction improvements associated with the Estates at Maple Ridge, be reduced to any amount less than Two Million, Five Hundred Eleven Thousand, Five Hundred Eleven Dollars and Twenty-Seven Cents (\$2,511,511.27).

MOTION: Supervisor Moore made a motion to grant credit release number 2 in the amount of \$228,936.58 for the Estates at Maple Ridge and WB Homes, per Jeffery Ott's letter dated September 13, 2022.
