The Township would be responsible for application, administration and following all the Municipal Regulations for specifications, bidding, and prevailing wage. These factors would drive up the cost of the preservation.

Citizen's Fire Company is requesting that \$200,000 from the Township Capital Reserve fund held for Citizens' Fire be placed into a 180-day Term transaction with PLGIT. Today the rate for this transaction is locked into 5.04%.

In accordance with the request for release of secured funds dated October 31, 2022, we the undersigned hereby certify that the improvements required in connection with the O'Rourke Vineyard and Winery, have been completed to the extent that the security deposit can be reduced by the amount of Twenty Thousand, Four Hundred Three Dollars and Fifty-Three Cents (\$20,403.53) in accordance with the Improvements Agreement dated October 15, 2020. This certificate authorizes Upper Milford Township to reduce said amount, namely Twenty Thousand, Four Hundred Three Dollars and Fifty-Three Cents (\$20,403.53) to owner or such other person as said owner shall designate. This authorization shall not be construed as final acceptance of improvements made to date. In no event, shall the escrow fund for the construction improvements associated with O'Rourke Vineyard and Winery, be reduced to any amount less than Thirty-Two Thousand, Four Hundred Forty-Seven Dollars and Thirty-Five Cents (\$32,447.35).

- 1.) Yeakel's Mill Rd Bridge Concern
  - a. Email from Chris Mitchell

My name is Kristen Mitchell and I live on Brookshire Drive in Zionsville. I called into the township today to express my concerns/frustrations with the one lane bridge at Yeakel's Mill Road and route 100. This bridge is a major safety concern and an accident waiting to happen. I have had several incidents where I am coming off of route 100 from each direction to have to stop abruptly because someone has run the stop sign and left me no place to go (happened today at around 1:30 pm), or this afternoon as I picked my daughter up from school there were three cars stacked across the bridge and again as I come off route 100 I had no place to go. It is a miracle I have not been rear ended on this bridge. It was explained to me that this bridge was repaired in the last several years and not made to be a full two-lane bridge due to other government/environmental agencies decisions, and the township did not have the a say either way. And since it was just completed in the last several years, the chances of it being expanded are unlikely to happen. The township can put up more signs but clearly people ignore them anyway. The best and safest solution would be to expand the bridge to two full lanes...this is the only practical and safe suggestion I can make. I want this email to be shared with the board members of this township in hopes someone will take my concerns seriously to prevent a disaster in the future.

There was a discussion of the traffic in the area, the approach to the bridge. It was noted that the bridge was replaced within the last 5-10 years. Staff was directed to investigate other optional signage if possible and paint a stop bar on the approach to the bridge opposite Rt 100 to help caution motorist to stop prior to crossing to the Rt 100 side.
