1.) Nonnemacher Farm Preservation Appraisal Discussion.

The Township has received the Agricultural Conservation Agreement Appraisal Report for the Nonnemacher property at 4246 Main Rd. E. Emmaus. A copy of the appraisal information is attached, along with the Natural Resource Area Plan mapping information. This is the property we discussed as a joint preservation with Lehigh County at the February 2nd, 2023, Supervisors meeting. The property is depicted with several natural resource features and is adjacent to other Agricultural Preserved & Natural Resource Area Preserved property. At this time, I would like to move forward in the preservation process and submit this property to the Township Open Space Committee for review & a recommendation for the Board of Supervisors.

There was a brief discussion. The matter will come back to the Board of Supervisors with review and recommendation from the Open Space Committee. The County is putting in \$44,960.00 and the township the remaining. The county will also take care of drafting the agreement and the Survey of the property. The Township and County funds are approximate until the survey is complete and shows exact acreage.

Phil Casey asked where the funds would come from and if there is a balance in the account. Supervisor Moore answered the funds will come from the Open Space Referendum Fund and there is a balance in the account.
