UMYA has requested that a soccer kick wall be installed at Jasper Park in order for the soccer teams to be able to run practice drills and paint their soccer Logo on it. The Recreation committee has now made a recommendation to the Board of Supervisors that the kick wall be allowed to be installed at Jasper Park along the end of the soccer field opposite of the houses to limit noise concerns for residents.

MOTION: Supervisor Senter made a motion to allow staff to work with Public Works and UMYA on the development and installation of the soccer kick wall with appropriate signage to limit incorrect usage of the wall.
